Meeting Agenda & Minutes

- Meeting started at 9:04 AM. Pastor Pan opened in prayer.
- Pastoral Sharing
 - September is the first month we moved to full reopening
 - CM
 - Sunday service: less than ⅓ of congregation returned to sanctuary (average 183 onsite, 280 online)
 - 4-5 fellowships returned to church on Friday and Saturday
 - Most Sunday school classes keep hybrid, some keeps online only
 - Many newcomers (around 55 total)
 - Parents of youth and children are more willing to return
 - The hybrid model did affect fall evangelistic meeting not on attendance
 - CB
- Sunday service: average more than 100 onsite attendance, around 40 online. Onsite numbers continue growing
- Cross generational fellowship return to church on Friday
- A few BBQ after church; it works to attract people to return
- YM
 - The attendance of Sunday school is between 30 and 40 (good attendance)
 - Sunday: Above 100, around 90% of original popultation
 - Some youth feel hungry after Sunday service if no BBQ
- Children Ministry
 - Keep stable attendance on Sunday (around 35) and Friday (more than 50)
 - Start Philly program
 - Need more coworkers support
- COM
 - Sunday Service: around 100 onsite and 50 online
 - Friday Fellowship: student fellowships onsite, Young Professional hybrid, and family online
- General observation
 - The demographic of age affects intention of returning
 - The shortage of coworkers is the general status because not all are ready to return
 - Many newcomers, but less coworkers the issue of follow-up
 - Appreciate some coworkers' commitment: Worship, AV and IV, IT, ushers, teachers of

- Lunch/food provision play sort of critical factors in attracting people back, how about coffee service?
- Hybrid status did affect some ministries evangelistic meeting, Sunday schools, fellowship Bible study, Retreat registration
- What can we do to call people back onsite?
 - What are the difference between online and onsite?
 - Food supplies, opportunities of in-person relationship, opening appreciation to returning coworkers
 - We have to respect everyone's comfort levels

 - For example "Put Your Mask On" may need to be adjusted



IRS Publication 526 (2020), Charitable Contributions

Contributions From Which You Benefit

If you receive a benefit as a result of making a contribution to a qualified organization, you can deduct only the amount of your contribution that is more than the value of the benefit you receive. Also see <u>Contributions From Which You Benefit</u> under <u>Contributions You Can't Deduct</u>, later.

If you pay more than fair market value to a qualified organization for goods or services, the excess may be a charitable contribution. For the excess amount to qualify, you must pay it with the intent to make a charitable contribution.

Example 1. You pay \$65 for a ticket to a dinner dance at a church. Your entire \$65 payment goes to the church. The ticket to the dinner dance has a fair market value of \$25. When you buy your ticket, you know its value is less than your payment. To figure the amount of your charitable contribution, subtract the value of the benefit you receive (\$25) from your total payment (\$65). You can deduct \$40 as a charitable contribution to the church.

Example 2. At a fundraising auction conducted by a charity, you pay \$600 for a week's stay at a beach house. The amount you pay is no more than the fair rental value. You haven't made a deductible charitable contribution.

Charity benefit events. If you pay a qualified organization more than fair market value for the right to attend a charity ball, banquet, show, sporting event, or other benefit event, you can deduct only the amount that is more than the value of the privileges or other benefits you receive.

If there is an established charge for the event, that charge is the value of your benefit. If there is no established charge, the reasonable value of the right to attend the event is the value of your benefit. Whether you use the tickets or other privileges has no effect on the amount you can deduct. However, if you return the ticket to the qualified organization for resale, you can deduct the entire amount you paid for the ticket.

- Annual Meeting Voting Update
 - 252 Mail-in ballots received, need 345 ballots to achieve quorum
 - Mailed out 360 ballots
 - Recruited people to serve voting booth and counting for Sunday
 - Voting booth opens at 9am
 - One booth for dropping off mail-in ballots

- Elbert and Samuel will be at COM
- Mission/SCM Conference Update
 - o The speaker from Taiwan is recording their sessions remotely
 - Hybrid conference
 - Friday session is completely virtual
 - Poster to be created shortly
- Coffee in Lobby Discussion
 - CB is starting to serve coffee starting 10/10
 - There is a desire to move the coffee station indoors as the weather gets colder
 - Proposed location would be in the lobby by the doors to the sanctuary



- Coffee spills can happen
 - Coffee lid stoppers would be given
 - Suggest more consistent carpet cleaning to elongate carpet lifetime
- Other thoughts
 - Would coffee in the lobby encourage people to linger in the lobby before CB service, leading to congestion?
- Initial Proposal:
 - Move to chapel as there is no food or drink in the lobby
 - Current COVID policy does not prevent one to eat indoors
 - Policy change may need to be required to allow eating/drinking on the carpet
 - Therefore, we would need to increase carpet cleaning
 - If we do not change the policy, then the coffee ministry would need to serve coffee in the chapel
- BOD Feedback
 - Please try using the chapel when the weather gets cold as chapel is not fully utilized now
 - Pastoral staff to follow-up with full proposal
 - The welcome corner could be utilized to serve coffee in the future
